Event Information: The show will occur whether it rains or shine!

- **Location:** Gunston Hall address is 10709 Gunston Road, Lorton, VA 22079. Lorton, VA is located on the Mason Neck area near the Potomac River. Please see the driving directions below.
- **For Food Vendors, BOG Lunch Hours:** Approximately 10:00 am to 1:00 pm. Please allow enough time for your site setup to begin serving no later than 1030 a.m.
- **For other Vendors:** Show field opens at 9:30. Please allow yourself enough time to setup for the show.
- **For all Vendors:** There is no electric power available on site. Please be prepared to supply your own power.
- **Cost:** There is a \$75.00 site fee. Fee can be prepaid or is due aid by the end of the car show.

Directions to Gunston Hall:

From Washington, Baltimore and other points North: From Interstate 95 South take Exit #163.

- Turn left onto Lorton Road.
- Turn right at the third light onto Lorton Market Street which becomes Gunston Cove Road.
- After crossing Richmond Highway (Route 1), Gunston Cove Road becomes Gunston Road (SR 242).
- The Gunston Hall entrance is 3.5 miles on the left.

From Richmond, Fredericksburg, and other points South: From Interstate 95 North take Exit #161 onto Richmond Highway (Route 1)

- North. Turn right at the first light onto Gunston Road (SR 242).
- The Gunston Hall entrance is 3.5 miles on the left.

From Mount Vernon via the George Washington Parkway:

- From the Mount Vernon entrance continue South on Route 235.
- Turn left on Route 1 and continue south for 5.4 miles.
- Turn left onto Gunston Road (SR 242).
- The Gunston Hall entrance is 3.5 miles on the left.
